3. Import a visa application.
4. Send and receive an application from a different account.
5. Remove visa applications that are no longer relevant.
6. Send or receive an incomplete visa application from a different account.

## How to Edit your ImmiAccount?

To maintain security and accuracy, it is advisable to make periodic updates to your ImmiAccount:

1. Changing password:
  - Log in to your account, go to "Manage Account," and click on "Change my password."
  - Set a new password containing uppercase, lowercase letters, digits, and special characters.
2. Changing your email:
  - Log in to your ImmiAccount, select "Manage Account," and go to "Edit email address."

- Add your new email address and save the changes.
3. Updating your secret questions:
    - Go to "Manage Account," click on "Change my secret questions," and update the questions and answers for added security.
